#### ARTICLES OF INCORPORATION

#### SOUTH KESWICK OWNERS ASSOCIATION

#### I. NAME

The name of the corporation is:

#### SOUTH KESWICK OWNERS ASSOCIATION

#### II. PURPOSE

The Corporation is intended to assume the powers and obligations of the South Keswick Owners Association, which was established November 16, 1987, in Fluvanna County, Virginia, as a non-profit association for the administration of restrictive covenants that apply to lots within the South Keswick subdivision. The Corporation is organized as a Virginia nonstock corporation to be a property owners' association for the South Keswick subdivision in Albemarle County, Virginia, and in connection therewith, to take over operations of the current South Keswick Owners Association and to conduct any and all business which may lawfully be conducted by such an association.

No part of the net earnings of the Corporation will inure to the benefit of, or be distributable to, its members, directors, officers or other private persons, except that the Corporation is authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purpose. The Corporation will not participate in or intervene in (including the publication or distribution of statements regarding) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the Corporation will not carry on any other activities not permitted to be carried on by a Corporation exempt from Federal income tax under Section 528 of the Internal Revenue Code (or a corresponding section of any future Federal tax code).

Upon dissolution of this Corporation, the remaining assets, after paying all expenses and debts of the Corporation, will be distributed either to any successor entity or, if there is no such successor entity, in a manner that is appropriate under applicable Virginia and Federal law.

#### III. MEMBERS

All provisions regarding classes of membership and the rights of members will be set forth in the Bylaws of the Corporation.

#### IV. REGISTERED AGENT/REGISTERED OFFICE

The initial registered agent of the Corporation shall be William W. Tanner, who is a resident of the Commonwealth of Virginia, and an attorney licensed to practice law in the Commonwealth of Virginia. The address of the registered office is 412 East Jefferson Street, Charlottesville, Virginia, 22902. The registered office is located in the City of Charlottesville.

#### V. DIRECTOR SELECTION

Directors of the Corporation will be elected at an annual meeting of the membership of the Corporation, by simple majority vote, as provided in the Declaration.

#### VI. LIMIT ON LIABILITY

No director or officer of the Corporation will have any liability in any proceeding by or in the right of the Corporation or by or on behalf of the Corporation's shareholders, unless the director or officer is found to have engaged in willful misconduct or a knowing violation of the criminal law or of any federal or state securities law.

#### V. INDEMNITY

Any individual who was, is or is threatened to be made a party to any proceeding (including any civil, criminal, administrative or investigative action, suit or other proceeding and any appeal of such a proceeding, whether by or in the right of the Corporation or its shareholders or otherwise) because such individual is or was a director or officer of the Corporation and was serving the Corporation or, at the request of the Corporation, any other entity (including another Corporation, a partnership, an employee benefit plan or any other organization) in any capacity will be indemnified against any liability and expenses reasonably incurred in such proceeding. Service as a director or officer of any entity controlled by the Corporation will be considered service at the request of the Corporation. Indemnification will not be made, however, if the individual is determined to have engaged in willful misconduct or a knowing violation of the criminal law or of any federal or state securities law. An individual who is or is threatened to be made a party to any proceeding will be entitled to receive advances for expenses reasonably incurred in such proceeding if there has not yet been a determination that the individual is not entitled to indemnification, and if the individual agrees to reimburse the Corporation for any advances in the event that the individual is determined not to be entitled to indemnification.

The Corporation may indemnify any individual acting as an agent or employee of the Corporation to the same or a lesser extent as provided for a director or officer of the Corporation. An individual serving as a fiduciary of an employee benefit plan which is established for employees of the Corporation or any entity controlled by the Corporation will be entitled to indemnification to the same extent as a director or officer of the Corporation.

The Corporation may purchase insurance to provide for indemnification for any individual, even though the Corporation may not be entitled under this article or applicable law to indemnify the individual.

The determination of the reasonableness of expenses and the applicability of indemnification will be made by a majority of a quorum of directors not parties to the proceeding or, if such a quorum is not available, by a committee of two or more directors not parties to the proceeding. The quorum of directors not parties to the proceeding or the committee may instead have the determination made by independent counsel, who may be counsel to the Corporation, or by the shareholders.




