## SECOND SUPPLEMENTARY DECLARATION TO AMENDED AND RESTATED DECLARATION OF RESTRICTIONS, COVENANTS AND CONDITIONS

THIS SECOND SUPPLEMENTARY DECLARATION is made this 12 day of May, 1993, by J & W Partnership, a Virginia partnership, hereinafter referred to as the "Declarant"

## WITNESSED:

WHEREAS, by Amended and Restated Declaration of Restrictions, Covenants and Conditions dated November 16, 1987 (the "Declaration"), recorded in the Clerk's Office of the Circuit Court of Fluvanna County, Virginia, in Deed Book 185, page 182; the Declarant subjected certain real property as therein described to the covenants, restrictions, easements, conditions, reservations,

WHEREAS, by Amendment to the Declaration dated June 29, 1988, precorded in said Clerk's Office in Deed Book 191, page 499, the Declarant revised and re-subdivided Lot 10 and Lot :2, South Keswick (the "Amendment");

WHEREAS, by Supplementary Declaration dazed March 29, 1990,

recorded in said Clerk's Officer in Deed Book 210, page 254, the Declarant subjected certain real property as therein described to the covenants, restrictions, easements, conditions, reservations, liens and charges and all mother provisions therein set forth;

WHEREAS, the Declarant is currently the owner of additional real property described in Exhibit B attached to the Declaration ("Additional Property"); and

Aubrey Huffman & Associates, Ltd., dated April 14, 1993, consisting of six (6) sheets, captioned "Plat Showing Lots 36 Thru 56, South Keswick, Fluvanna County, Virginia", attached hereto and recorded herewith (the "Plat");

WHEREAS, the Declarant desires to revise Lot 6, South Keswick, pursuant to Section 3.06 of the Declaration;

NOW THEREFORE, the Declarant does hereby declare that "Par. X" containing 1.00 acre and Lots 36 through 58, South Keswick, as shown and described on the Plat are hereby brought within the plan and operation of the Declaration and made subject to the covenants, restrictions, easements, conditions, reservations, liens and charges and all other Provisions as set forth in the Declaration; and that Lot 6 is hereby revised as shown on the Plat to contain 11.053 acres.






